

Terms & Conditions

For Joining as a Promotional Business Associate / Rank Holder

1. The opportunity to join as a **Promotional Business Associate or Rank Holder** is open to individuals, sole proprietors, partnership firms, companies, and other legally recognized institutions. The applicant must be **at least 18 years of age and a citizen of India**. Joining must be done voluntarily without any pressure or compulsion.
2. By joining **Prominent Future Vision India (PFV India)**, the Associate will get an opportunity to promote the services or packages offered by the Firm. However, the Associate will **not be considered an employee or agent of the Firm** and will work as a **self-employed independent associate**.
3. All incentives, bonuses, and payments shall be made by the Firm **through online bank transfer or UPI to the Associate's registered bank account, as per the records maintained by the Firm**.
4. **Statutory deductions such as TDS, GST, or other applicable taxes** will be deducted as per the prevailing government rules at the time of payment.
5. The Firm may deduct **administrative or operational charges** as per the existing rules of the Firm from time to time.
6. The Firm will **not be responsible for delays or non-performance** caused by natural calamities, acts of God, and changes in law, government intervention, technical issues, or other unforeseen circumstances.
7. The Firm will **not be liable for any website malfunction**, hacking, virus attacks, or technical interruptions. Associates are advised to confirm any important information directly with the Firm's office if required.
8. The Firm reserves the **right to modify or change the business plan, prices, policies, or terms and conditions at any time**. Such changes will be considered effective once published on the official website of the Firm.
9. Benefits, incentives, or pay-outs are **performance-based bonuses** and will be paid only when the Firm earns profits. The decision of the Firm in such matters shall be **final and binding**.
10. Filling an application form and getting enrolled as an Associate **does not entitle the person to represent themselves as an employee or agent of the Firm**.
11. Login PIN or ID will be issued **only after the payment is successfully received and verified** by the Firm. Payments must be made through approved channels only.
12. Associates must **inform the Firm in writing about any change in address, contact number, bank details, or nominee information**.
13. If any information provided by the Associate is found to be incorrect, **the Firm will not be responsible for any resulting loss**.
14. An Associate **cannot transfer or assign their ID to any other person during their lifetime**, except to their nominee in case of death, subject to proper documentation.
15. The Firm **does not accept deposits** from Associates.
16. Associates **must not misuse the Firm's trademark, brand name, logo, or copyrighted materials** without prior written permission.
17. Associates must **avoid misleading, illegal, unethical, or immoral activities** while promoting the Firm's products or services.

18. Associates must **truthfully explain the business plan, opportunity, and policies** to prospective members.
- The following activities are **strictly prohibited**:
 - Promoting schemes that depend only on enrolment of members
 - Promising quick or easy money
 - Violating the **Prize Chits and Money Circulation (Banning) Act, 1978**
 - Forcing or pressuring anyone to join the business
20. If any Associate is found violating these rules, the Firm may **suspend payments, cancel the user ID, or take legal action** as per the decision of the management.
21. All legal disputes, if any, shall be subject to the **jurisdiction of the Courts at NCR Delhi**, where the Head Office of **Prominent Future Vision India** is located.
